





DISCUSSION GUIDE – STAKEHOLDER INTERVIEWS

STATE LIBRARY NSW – REGIONAL MANAGEMENT MODELS RESEARCH

- 23. What opportunities/benefits do you think could result from regional libraries/shared services in communities across NSW?
- 24. What is the **overall value** that libraries add to the local/regional community?
